Our speaker for the July 1st meeting will be Elad Gross. Mr. Gross has dedicated his entire adult life to serving the people of Missouri. He is a constitutional attorney who served as Assistant Attorney General until the end of 2016 and represented Missourians in courts throughout the state. Since then, Elad has fought for better government in Missouri by investigating and suing a dark money

organization trying to buy Missouri's elections. He has also sought to enforce Missouri's government transparency laws and pushed for fairness in our underfunded education and criminal justice systems. Elad has worked with families, small business owners, government officials, and law enforcement officers to build a better Missouri for all. Elad is a trial attorney who has litigated cases in administrative settings, state courts, federal courts, and courts of appeal. He left the Attorney General's Office in 2016 and started another nonprofit organization called Missouri For All to teach adults and youth throughout the state how to have their voices heard in our government and communities. He also volunteered as a Special Public Defender in St. Louis City, and he secured the freedom of a teenager who had been held in jail for 7 months for a crime she did not commit. Elad has been working on making our state's criminal justice system fairer for everyone.

When asked why he was running for Attorney General he said, "We need a chief law enforcement officer who will enforce the law, who won't favor big-money out-of-state donors over the people of our state. We need a government that cares less about a few wealthy people's pet projects and more about hospital closures in rural Missouri, poor kids going to poor schools, and the many folks in our state whose voices have been ignored for far too long. **We need to take back Missouri**."
